UNCONSTITUTIONAL: An American Story is an explosive docuseries that confronts threats to American democracy during the COVID-19 pandemic. It reveals a coordinated effort to undermine Constitutional Rights through political manipulation, leading to public distrust, inflation, and societal division.

Anthony Delmedico and his crew captured important events in four different American cities, and perspectives from a wide variety of American citizens on those streets from every background, race, and pedigree.

UNCONSTITUTIONAL: An American Story begins on March 5, 2020 during the COVID-19 Pandemic and the Unconstitutional Lockdown of 333M+ American Citizens. Anthony heads out with his film crew across America, at a time when many Americans were afraid to go outside, to find out what was really going on, and give Americans a voice.

(Episode #1): “The Angry Mob”

PHOENIX, ARIZONA – AZ STATE CAPITAL IS STORMED – 4/5/2020

DAY 30 of the Unconstitutional LOCKDOWN of America. Filmmaker Anthony Delmedico and his crew venture into the heart of protests at the Arizona State Capitol in April 2020. As many Americans hesitated to step outside, Anthony captures a compelling narrative filled with armed citizens, shuttered business owners, unemployed parents, and confused individuals—collectively seeking their voices in a disabling situation. On the historically significant day when armed individuals stormed the AZ State Capitol, they discovered it largely unoccupied by government officials. This protest received minimal media coverage, reflecting the atmosphere of fear gripping the nation. Touching on the Bill of Rights, Anthony, a former U.S. Infantry Soldier, remembers his oath to protect against all enemies, foreign and domestic. The episode also traces the origins of COVID-19 to the Wuhan Lab and exposes the politicization of the pandemic by key governors and mayors, revealing a massive “money trail” that benefited politicians and pharmaceutical companies, resulting in forced vaccines, unnecessary lockdowns and many deaths, as well as an increase in societal issues like addiction and depression. As the lockdowns continued, various political actors and media entities created chaos and division across America, all while complicity rigging future elections.

CHICAGO, IL – BUCKINGHAM FOUNTAIN – MEMORIAL DAY RALLY – (5/20/2020)

DAY 76 of the Unconstitutional LOCKDOWN of America. Anthony organizes a Memorial Day Rally at Buckingham Fountain to “Honor the Fallen.” This powerful assembly seeks to pay tribute to the lives lost during this tumultuous time and to protest the city ordinance that allows no more than ten people to gather in public parks, as well as the illegal “stay-at-home” orders that have stifled freedoms across the nation. This episode explores the grave violations of Constitutional Rights that have occurred during the pandemic, particularly focusing on free speech and the right to assemble. When hundreds of military veterans and influential voices gather to express their views openly, they represent not only those lost but also the fundamental American principle that citizens have the right to gather and voice their opinions. "Honor The Fallen" is a gripping exploration of courage in the face of adversity, revealing the resilience of ordinary Americans fighting for their rights and honoring those affected by government mandates during the unprecedented COVID-19 pandemic.

(Episode #3): America is Burning!

MINNEAPOLIS, MN – GEORGE FLOYD PROTEST, A CITY ON FIRE – JUNE 2020

Day 90 of the Unconstitutional LOCKDOWN of America. Anthony heads to his hometown and films the social unrest, rioting and looting where 148 buildings are burned to the ground. He captures non-local agitators clearly engaged in “stirring the pot”, including starting that first building fire, mysterious vans dropping crates of bricks, fliers with offers to be paid looters. He shows a military operation of “key agitators” that turned a peaceful protest into a burning city of lawlessness, which eventually became the same fate for many cities across America, carried out by the same playbook, and the same players. Combine that with the Media Frenzy of race baiting, social divide, and millions of citizens being forced to stay at home, shut up, and consume what was delivered to them, and all hell broke loose! Anthony peels back the layers, and begins to show proof of larger forces at work, both domestic and global, enjoying the burning of America, and eventually impacting the POTUS Elections on NOV 2020.

EAGLE PASS, TX - THE CONSTITUTIONAL BORDER CRISIS – FEB 2024

This episode shines a light on the Constitutional Border Crisis, unfolding under the pretense of humanitarian efforts while revealing a disturbing truth: one of the largest waves of illegal human trafficking in recorded history. As Anthony and his team investigate the complexities surrounding this crisis, they uncover a harrowing reality. Many migrants, including vulnerable children, are lured by false promises and become victims of heinous crimes. These include human and sex trafficking, theft, and even death—often occurring long before they reach the United States. Anthony will setup up his mobile "Voice of Free Enterprise" Podcast at the sneak previews, launch parties, and Premiers, to get Voices of The People heard, while also while promoting the trailers, premieres, release dates, and launch of *UNCONSTITUTIONAL: An American Story*, growing new organic fans on the streets. We intend to host three large Premiers during the month of October, releasing some of the first full episodes for private screening and public consumption. The location of these Film Premiers will be selected based on feedback from our Film Partners. Premier invitations will go to select VIPs, Sponsors, Film Partners and their Guests, the Press, and to some members of our new, fast growing fan base.

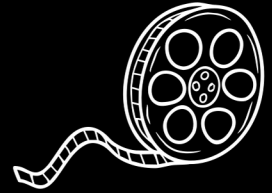
FINANCIAL PROJECTIONS

There are roughly 250M+ American Citizens, from 18-65+, which is essentially our general target market for streaming these first 6 episodes leading up to November 2024.

REVENUE PROJECTIONS: STREAMING DOWNLOADS *PER EPISODE

Market Share Capture- 5% x 250M = 12 Million X \$9.99/episode = \$125M

- First Year = \$125M + Revenues (2024-2025)

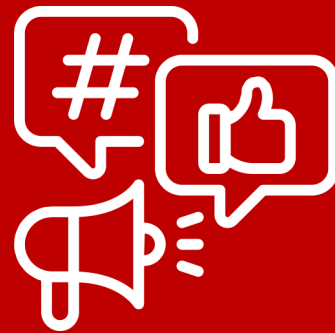
